3 Qualifying Performance and Trial Event in which the particular performance was achieved.

Failure to appeal according to the protocol above will lead to automatic failure of the appeal.

Please note that no other reasons, other than a qualifying performance as per the Boland Athletics Cross Country Selection Criteria will be considered for selection.

School Athletes will still be given the opportunity to qualify for the Final 2018 Boland Athletics Cross Country Team during the Western Cape Schools Cross Country Championships on 25 August 2018 at Dal Josaphat Stadium, Paarl.
