### ASA CIRCULAR 25 OF 2020 - ASA OFFICE REMAIN ON SKELETON STAFF, WORKING FROM HOME, UNTIL FURTHER NOTICE

Dear ASA Members

The declaration made by the State President Mr. Cyril Ramaphosa on Sunday 15 March 2020 to curb the spread of the Coronavirus in South Africa has bearing. The follow-up declaration made by the State President Mr. Cyril Ramaphosa on Monday 21 March 2020 has also bearing. In summary, South Africa will go into lockdown for three weeks from midnight on Thursday 26 March 2020.

South Africans would have to "stay at home" until midnight on April 16. During the lockdown, individuals will not be allowed to leave their homes except under strictly controlled circumstances – including to seek medical care; to buy food, medicines or other supplies; or collect social grants.

ASA Circular 24 will remain effective until further notice, and as promised, ASA will notify Members of any new developments as announced by State President Mr. Cyril Ramaphosa.

Please note that the 2020 Olympic Games and the 2020 WA u/20 World Championships have been postponed until further notice.

The status of ASA events remain unchanged. Please refer to the attached updated 2020 ASA Fixtures List (STATE OF DISASTER UPDATE 25 MARCH 2020).
