**CIRCULAR 7 OF ASA 2020
ASA SUSPEND SASA EXECUTIVE AND APPOINT INTERIM COMMITTEE**

Dear ASA Members

ASA Members were briefed at the 2019 ASA Council Meeting in October 2019, of the process of alignment of SASA School Athletics with ASA Athletics. Several consultations took place between the ASA Executive and SASA Executive in this regard, to ensure a seamless alignment of SASA with ASA.

It became clear to the ASA Executive that the SASA Executive were resisting the required alignment with ASA, and deliberately mislead the SASA Council regarding the mandate received from ASA.

With the above in mind, on Monday 20 January 2020, the following SASA Executive was suspended with immediate effect: Mr. Willy Mokatsanyane; Mr. Sabata Khumalo; Mr. Peppi Olevano; Ms Yvonne Schalk; Mr. Victor Modimokoane; Mr. Dawid Pieterse; Mr. Hendrik Bekker; Mr. Peter Maluleke; Mr. Wimpie Lodewyk; Ms Erika Clarence.

The abovementioned SASA Executive Members are, with immediate effect not allowed to serve on any ASA National Structures, which include the ASA Board, ASA Council, ASA National Commissions and ASA National Committees.

On Friday 24 January 2020, ASA called an urgent meeting with the 9 ASA Provincial Presidents (and Coordinating Presidents), as well as the 9 SASA Provincial Chairpersons.

During the mentioned meeting, an SASA National Interim Committee, consisting of Mr. Brandon Du Plessis (Chairperson) and Mr Sibusiso Nyamane (Vice Chairperson) was appointed. The primary, and short term responsibility of the SASA Interim Committee will be to ensure that the following events are successfully hosted under the guidance of ASA:
