FINAL UPDATE OF 2018 SAAS T&F TOP 10 RANKING LISTS**

Dear ASA Members

Please find attached the final update of the 2018 SAAS Track & Field Top 10 Rankings.

ASA Members must keep in mind that SAAS are dependent on the results of competitions that took place under the auspices of ASA Members, to accurately update SAAS Top 10 Ranking Lists.

SAAS notified ASA that they receive many results from parents and coaches, which are good enough to be listed on the SAAS Top rankings.

These results from parents and coaches however cannot be recorded as the official result for the province is required. This is in line with IAAF Rules, whom require an electronic copy of the original competition results before performances of athletes can be ranked on the IAAF World Rankings.

ASA Provinces are therefore requested to remind Competition Organizers to forward the results of the competition to SAAS asap.

In view of the National Team to represent South Africa at the 2019 African Youth and Junior Championships in April 2019, it is important that the ASA Ranking Lists is updated with the most recent performances of athletes.

The ASA National Coaches Committee is currently updating the ASA Squads, and the ASA National Selectors will be using the squads and Top 10 Ranking lists as reference when selecting teams to represent South Africa.

Please find attached the following lists as updated in December 2018:

1. ASA Senior Top 10 Ranking list
2. ASA Junior Top 10 Ranking list
3. ASA Youth Top 10 Ranking list.
